On June 26 and June 27, 2023, Buildings & Grounds (B&G) staff entered the Dennis Mosaic (Dennis M) and Dennis Kaleidoscope (Dennis K) buildings to isolate the areas of suspect structural integrity and the adjoining spaces to limit access to <u>AUTHORIZED PERSONNEL ONLY (as determined by Director of Buildings & Grounds)</u>.

The following information is being provided to define the guidelines and timelines for moving building contents. Note: B&G is prepared to pack all classrooms in areas A & B and deliver the contents to the new location. Any items that are not packed, moved, or retrieved from the following locations by Wednesday, July 12, 2023, at 2:30 p.m. will be packed and moved by B&G staff. Please click here to view a sign-up sheet that shows when staff will be in the buildings.

See the attached floor plans which denote the various areas:

Area A – office and administrative area

Area B - classrooms, corridors, stairwells, and common areas accessible to DPS staff

Area C – areas only accessible to authorized B&G personnel

Area X – areas off-limits to ALL DPS staff

Building staff ONLY (no friends, no family, nor other non-DPS assistance) will be allowed to enter designated areas denoted as "Area A" and "Area B" (see attached floor plans) at scheduled times to pack and retrieve their personal belongings. All personal belongings should be placed into boxes/containers provided by DPS (as needed). Custodial staff will be on-site to assist in moving and delivering those items to the threshold of the building for the employee to be placed into their personal vehicle. Employees will be compensated as agreed upon with their respective bargaining unit. If an employee opts to forego entering the building (Area A or Area B) to gather their personal items for themselves, DPS will provide this work on behalf of the employee. Only authorized B&G personnel will be allowed to enter Area C; Area X remains off limits to ALL DPS staff.

Decatur Public Schools received a notice on Thursday, July 13, 2023, from the Illinois Department of Labor that an OSHA complaint had been filed on Thursday, July 6, 2023, regarding Dennis Lab Schools. The OSHA complaint alleges that the building is closed and yet employees are present coming in and out of the building, and that there is mold and asbestos present in the Dennis facilities. As a result of this complaint, **DPS is prohibiting any further access to the Dennis Lab School buildings and will be closing off all access points to the buildings.** All contents that have yet to be moved will remain in the facilities, as access is now prohibited.
