Decatur Public Schools received a notice on Thursday, July 13, 2023, from the Illinois Department of Labor that an OSHA complaint had been filed on Thursday, July 6, 2023, regarding Dennis Lab Schools. The OSHA complaint alleges that the building is closed and yet employees are present coming in and out of the building, there is mold and asbestos present in the Dennis facilities. As a result of this complaint, DPS is prohibiting any further access to the Dennis Lab School buildings and will be closing off all access points to the buildings. All contents that have yet to be moved will remain in the facilities, as access is now prohibited.

We have contacted all union leadership and they have received a copy of this notice. Kent Metzger has responded to the complaint, and I have completed the document regarding notification as well. In addition, a press release is being sent so everyone will understand why we are shutting down all activities.

In response to your July 10, 2023 letter referring to Illinois OSHA Complaint #2051352, Decatur Public Schools (DPS) offers the following:

The complaint references a "notice of alleged hazard(s)" at our workplace located at 520 W. Wood Street, Decatur, IL 62523. DPS acknowledges that the building has been closed due to concerns about the structural stability of the upper masonry exterior of the building. DPS acknowledges that there are asbestos containing building materials (ACBM) present within the building at this location. As required by the Asbestos Hazard and Emergency Response Act (AHERA) and subsequent State of Illinois regulations, DPS has generated and maintained an Asbestos Management Plan for this building. To the best of our knowledge, there has been no disturbance (intentional or unintentional) of ACBM's in conjunction with the current concerns with structural stability of the masonry exterior. DPS acknowledges that mold (aka fungal growth or contamination) is present in all buildings. Concerns/complaints about mold (aka fungal growth or contamination) prior to the structural instability concerns were investigated. Previous investigations revealed that indoor concentrations were found to be lower than outdoor concentrations. Since those investigations, DPS has continued to maintain interior heating/cooling systems, has maintained building cleanliness and has addressed infiltration of moisture to reduce the potential for higher than desirable indoor concentrations. To the best of our knowledge, there has been no change in conditions which may have elevated indoor concentrations in conjunction with the current concerns with structural stability of the masonry exterior.

The specific nature of the alleged hazard(s) references "Dennis Lab/The main stairs are pulling away from the wall and mold [is] present throughout the building".

DPS does not acknowledge that main stairs are pulling away from the wall, as this condition has not been found to exist at 520 W. Wood Street (as referenced in the complaint letter), Decatur, IL 62523. Another DPS building, the Dennis Lab School is located at 1499 West Main (no referenced in the complaint letter), Decatur, IL 62522 has been found to have structural concerns associated with the main stairs. Access to this area has been restricted to all personnel since the condition was investigated by structural engineers and reported to DPS Administration. DPS acknowledges that mold (aka fungal growth or contamination) is present in all buildings. No recent concerns/complaints about mold (aka fungal growth or contamination) have been substantiated, noted or extensively investigated. DPS has continued to maintain interior conditioning systems, has maintained building cleanliness and has addressed infiltration of moisture to reduce the potential for higher than desirable indoor concentrations. To the best of our knowledge, there has been no change in conditions which may have elevated indoor concentrations in conjunction with the current concerns with structural stability of the main stair.

DPS acknowledges the complaint letter's reference to Standard 1910.22(d).

Per paragraph 1 on page 2 of the Illinois OSHA Complaint 2051352 letter, DPS has opted to immediately control any perceived hazardous conditions prior to performing any investigations. To control any perceived hazardous conditions, DPS is immediately curtailing access to the buildings located at 520 W. Wood Street, Decatur, IL 62523 and 1499 West Main, Decatur, IL 62522. Curtailing access applies to all DPS personnel. By curtailing access to the building, no one will be exposed to a potential unsafe and unhealthy working conditions.

Copies of the complaint letter have conspicuously been posted on both building locations.
