I started pulling this together last evening as I am concerned with availability and timing, so,

Please see attached TWO separate price sheets;

- The first is for a New Construction Six (6) classroom building with Alternate restrooms. This one has slightly smaller multi use restrooms BUT provides a small teacher workroom/break

area has a staff restroom and a janitor closet.

- The second is for a New Construction Six (6) classroom building with a standard restroom configuration, larger multi use restrooms, a staff restroom, IT closet and a janitor closet.

Both again are new construction; all finishes will be new with marker boards and tack boards in the classrooms. All internal electrical and plumbing fixtures will be ready for site connections by your staff. Obviously has the wall hung HVAC units with controls for each classroom. These will be extremely nice for the staff and students.

Also attached are basic floor plans for each, exterior elevations showing the look and the nice sized windows for natural light, and the site overview I sent you yesterday for base site layout.

Based on where we are as of today, the buildings are available at the moment AND Vesta can have delivered and installed by mid-August. As discussed yesterday, a commitment this week will secure the buildings and I can begin planning and scheduling. We can get final lease agreements in place next week.
